Participants must be residents of the Albany Housing Authority or part of a household that is participating in the Housing Choice Voucher Program (Section 8). Children ages 6-18 years may enter.

Three age categories have been created: 6-9 years, 10-14 years, and 15-18 years.

There will be one winner for each category. All posters should be on the topic of the theme for Fire Prevention Week 2012. The theme for this year is "Having 2 Ways Out!"

Winners will be announced the week of October 7-13, 2012, Fire Prevention Safety Week. Winners will be acknowledged in 1st, 2nd, and 3rd place in each age group.

All participants will receive recognition certificates for their contribution towards promoting Fire Prevention safety from The Housing Authority Insurance Group.

Submissions will not be returned.

Each poster or essay must have the following information written clearly on the back:
