Authorization to purchase Lithium Ion hardwired smoke and CO2 detectors (Kidde Model #21010408N) for \$30.24/ each and Lithium Ion smoke alarms (Kidde Model #21008697) for \$13.37/ each from Vertex and their distributor, City Electric (Minority Business Enterprise) of Oneida, NY. The total cost estimate is \$80,322.41. Both detectors feature 10 year Lithium Ion batteries and are required for commercial dwellings per NYS law passed on January 22, 2015 (attached) and must be installed no later than January 1st 2017.

In response to a question from the Board, Ms. D'Arbeau discussed the status of the Summer Camps sponsored by the Authority.

She, together with Commissioners Kimbrough and Bobb-Semple, did a site visit to the KID program and found it to appear well run and worthwhile. They did not visit the PAL site, but spoke with representatives and were satisfied with the program. They also have received information that the City Basketball program and the summer food program have been successful.

All of these programs are required to submit closing reports before final payment will be approved.

The Commissioners discussed the National Night Out activities and the contributions made by AHA staff and Tenant Associations at various sites. All agreed this is a valuable endeavor and AHA will support it again next year.

  - a. The closing for the financing of the first phase of the Ida Yarbrough redevelopment took place and was successful. The Authority was reimbursed for the expenses that it advanced for the project, and also received a portion of its Development Fee. Construction is underway.
  - b. The Authority is moving forward with an application for funding for Phase 2 of the Ida Yarbrough redevelopment project.
  - c. The Authority is working with the City in an effort to gain control of a site in the South End that could be put to use for the benefit of the neighborhood.
  - d. The Authority is working with UAlbany and Trinity to evaluate management of the Capital South Campus Center with hopes to make it even more responsive to neighborhood needs. .
