The Authority issued a Request for Proposals and received proposals from Capital One and Beekman Securities. The proposals were reviewed by a panel that determined the Capital One Proposal is most advantageous to the Authority and will substantially reduce the interest rate and debt service on the current CFFP Loan.

This program is funded by a grant from the United States Dept. of Agriculture. Covered costs are food costs and seasonal payroll. AHA attempts to run the program on a break-even basis.
