A. Monthly Management Report (Executive Director)

Mr. Longo reported:

- 1. The CIF application to cover the cost of the Laundromat that was built for public use in conjunction with the South End Phase III project was not approved.
- 2. The Kitchen in the Campus South Community Center is scheduled to be finished next week. Senior Services of Albany plans to move the Meals on Wheels Program in over a two week period and be ready to begin producing meals at CSCC on February 23rd. Schenectady County Community College has not yet received a sufficient number of applicants to run the planned Culinary Arts Classes. We will wait for the Meals on Wheels and SCCC programs to settle in before scheduling a Grand Opening for the Kitchen. The ATTAIN Lab and Clean Room programs are moving forward and are seen as great programs.
- 3. Our application to HCR for funding the Ida Yarbrough Rehabilitation Phase I project is pending. There is a possibility there will be funding for a bonus round in which we would apply to fund the second phase.

B. Monthly Financial Report (Deputy Director)

Mr. Ragsdale discussed the current financial status of the Authority and explained the graphs provided. The Federal Developments are currently at a deficit of \$132,755 which will be covered in the short run with a transfer from the Capital Fund.
