Steven T. Longo, Executive Director, acting as Temporary Chair, opened the meeting and requested nominations for Chair. Commissioner Lefebvre nominated Victor Cain to serve as Chair and Commissioner Mance seconded. There being no other nominations, the nominations were declared closed. All voted in favor and Victor Cain was declared Chair.

In the absence of the Chair, Mr. Longo requested nominations for Vice-Chair. Commissioner Lefebvre nominated Paul Mancino to serve as Vice-Chair and Commissioner Mance seconded. There being no other nominations, the Chair declared the nominations closed. All voted in favor and Paul Mancino was declared Vice-Chair.

Approval to enter into a 1 year contract beginning December 1, 2014 (RFQ # 0025-C-14-007) with options to renew annually for up to 3 additional years with Canon, Heyman & Weiss, LLP, Albany, New York for Legal Services relating to Construction and / or rehabilitation of low income housing financed through programs administered by New York State Homes and Community Renewal and compliance with New York State and Local Laws & Regulations affecting public and affordable housing, for an annual fee not to exceed the Amount of \$99,000.00. (Ratify)

RESOLVE that the Ida Yarbrough Homes Redevelopment project and all future projects be designated "smoke free" in accordance with the standards set forth under Section 7.16 Smoke Free Building of the Enterprise Green Communities Criteria of 2011. Specifically, implement and enforce a no-smoking policy in all common and individual living areas, and with a 25-foot perimeter around the exterior of all residential projects. The lease language shall prohibit smoking in these locations and specify that it is a violation of the lease to smoke. The no-smoking restriction applies to all owners, tenants, guests, and servicepersons. (Ratify)

Approval to enter into a Lease and any other documents or agreements necessary to effectuate the Lease of a portion of the premises at 200 south Pearl Street, including the second floor of the building, to Parsons Child and Family Services, Inc. for the purpose of managing its child and family services programs for an initial term of five (5) years beginning January 15, 2015 and at an initial rent of \$125,000.00 per year upon such additional terms and in such form as the parties agree, subject to approval of the Authority's General Counsel.

Approval to enter into a Memorandum of Agreement with the New York State Division of Housing and Community Renewal and its Housing Trust Fund Corporation to manage, for a fee, 255 & 257 Livingston Ave.; 272 & 274 First St.; 30 N. Swan St. & 134 Second St. during the period that HCR forecloses on and recovers them.

Approval to enter into a 3 year contract, with options for 2 additional 1 year extensions, with Bruce W. Shultis to serve legal process, including Notices of Petition & Petitions for Summary Proceedings to Recover Possession of Real Property at \$26.00 per service. Mr. Shultis is the current provider of these services and his previous contract was at \$25.00 per service. This service was procured through a Request for Proposals distributed to local firms and through the NAHRO Web Site, but Mr. Shultis submitted the sole proposal. He has provided excellent

service in the past and the current rate has been determined reasonable based on the responses received in the 2010 RFP.
