Non- Smoking Policy

South Mall Towers

South Mall towers has gone through a HUD RAD conversion program which yielded an additional 140 project based vouchers. The HUD Regional Office has awarded the voucher administration to the Albany Housing Authority

Fair Housing

AHA is in the process of obtaining an analysis of how the recent Supreme Court Decision and the following Rules issued by HUD will affect AHA specifically. We are particularly interested in any impact that this might have on the re-development of Ida Yarbrough.

Capital South Campus Center Kitchen Ribbon cutting.

The 3,300 square foot commercial kitchen at the Capital South Campus Center has been completed. The kitchen is a unique partnership if the Albany Housing Authority, Senior Services of Albany and Schenectady County Community College and was made possible with \$750,000 in funding from NYS

Homes and Community Renewal. The Kitchen complements the mission of the Campus Center by providing training and higher education opportunities to those seeking employment in the food service industry.
