## Q&A:

When will it start?

East wing (A units) will begin December 2022 and tentative finish October 2023. West wing (B,C, D & E units) will begin January/February and tentative finish October 2023

Why wait until Christmas?

It wasn't intentional but was due to delays in plans and financing

What if I don't have a phone?

The relocation team will post a schedule in the community room for all tenants.

What if tenants weren't at tonight's meeting?

A notice will be sent out to all tenants to include tenants that could not attend tonight's meeting

Are the relocations to houses, apartments, and hotels?

Mostly apartments including other AHA housing, some private but will be discussed individually with the relocation team

Will the building have better security?

We will most certainly look into it

Safety is not good and feel unsafe simply bringing garbage out and shouldn't have to live like this, what will change?
