Standard Notice to Vacate Agreement

You are required to provide a PROPER NOTICE to vacate per your lease terms. AHA strongly encourages that you give a 60-day notice to accommodate your search time and any briefing/inspection processes.

It is the policy of AHA to only approve unit transfers at the expiration of the initial lease term.

PROPER NOTICE TO VACATE

You are required to give a proper notice to vacate per your lease terms. AHA strongly encourages that you give a 60-day notice to accommodate your search time and the move process.

It is the policy of AHA to only approve unit transfers at the expiration of the initial lease term.

A proper notice means:

- You state in writing your name, address, and the date that you will vacate the property (the last day that you will living at the property, typically the last day of the month). We have attached a form for your use.
- Your landlord is entitled to a calendar months' notice. This means that if you give notice on the 5th of the month, your landlord does not have to accept notice for the 5th of the next month, you could be required to revise your notice to the end of the month.
- Your landlord must sign and date the notice to vacate, acknowledging when they receive it from you.
- If your landlord refuses to sign your proper written notice, you MUST mail a copy of the notice via certified mail to the landlord. You need to provide your caseworker with a completed copy of the certified mail receipt and a copy of the vacate letter to verify that the attempt to notify was made.

Once AHA has received and approved your proper notice to vacate, you will receive a voucher and all documents needed to begin your unit search and have your selected unit approved for occupancy.

Please note that if you are being evicted for nonpayment of rent or if you are not up to date on your rent payments to your current landlord, you will not be issued a voucher to move.

If you are in a repayment agreement for overpayment in rent, you are not able to port out of the City of Albany.

If you are pending termination for the violation of the Statement of Family Obligations, you MAY be issued a voucher, however, any prospective landlord will be notified that you are pending termination as part of the unit approval process.
